In 2018, GCY celebrated its 20th year of service, serving close to 10,000 young people in total. Programs typically run from March through October. During 201, GCY facilitated 82 outdoor education expeditions (river and land), serving a record 1,092 participants from across the country on 4,340 days in the outdoors. Programs took place on eight sections of river in Utah and Arizona, including Grand Canyon. The GCY program continues to be one of the most affordable programs of its kind, charging up to two-thirds less than commercial river trips. Participants paid only 50% of the actual cost of operating the programs in 2018; the rest was funded by grants, contributions & special events. Additionally, close to \$45,000 of financial aid was awarded to 176 participants during the year. Participants engaged in over 13,000 hours of community service during 2018, were required to earn a portion of the cost of their trip and be engaged in an educational project related to the cultural or natural history of the Southwest. (continued from above) The warehouse & office are based in Flagstaff, AZ. In 2018, GCY was a key partner in continuing to develop the Watershed Collective, an initiative to create a K-12 continuum of place-based integrated experiential education programs with three Flagstaff schools - an elementary, middle & high school. Additionally, GCY helped to develop the pilot Healing Lands program that connects youth who have experienced the effects of domestic violence to the healing power of nature and community. To leverage resources & further its mission, GCY continues to establish & maintain strong partnerships with many organizations, including both long-standing and some new: 22 schools, 3 land management agencies, 3 Native American tribes & 5 non-profit organizations during 2018. Partnerships with Glen Canyon Nat'l Recreation Area & the U.S. Geological Survey connected youth with service projects & scientists. In 2018, the GCY collaboration with the Verde River Institute continued to flourish, doubling day trip expeditions for youth on the Verde River in central AZ. (continued below)

(continued from above) A "citizen science" project is included on nearly every program. Projects include studying the health of bats & understanding the food base endangered fish need to survive. In addition to science, many programs include art themes (writing, painting, etc). GCY continued to receive excellent post-trip reviews from participants and their parents, 100% of whom would recommend GCY to others, and 100% who felt GCY provided an educational experience. The focus of GCY's programs continued to be not only the educational & community service curriculum, but valuing the teachable moments along with river, where learning is not an abstract concept but something real & hands-on for students. In 2018, GCY again expanded its endowment fund and the "Alumni Fund" where past participants are encouraged to contribute to financial aid for future participants.
