During 2025, GCY facilitated 61 expeditions, serving 846 youth participants from across the country who spent 4,037 days outdoors. This represents a 3% increase in youth user days over the prior year. GCY continues to be one of the most affordable programs of its kind, charging up to two-thirds less than other river trips. Participants typically pay only 25-40% of the actual cost of operating the programs; the rest is funded by grants, contributions & special events. Additionally, in 2025 over \$134,000 of direct financial aid was awarded to 423 youth participants, to help ensure cost is not a deterrent to participating. GCY strives to connect underrepresented and underserved youth to the river, including Indigenous youth, survivors of trauma, refugee youth, and youth who would otherwise never have such an opportunity.
